# **PRIVACY POLICY**

JAN MARIE KENNEDY (ABN 60 940 397 129) trading as JAN KENNEDY MASSAGE & PILATES (Jan Kennedy Massage & Pilates, we, our, us and includes any employee, servant, contractor, subcontractor, agent or officer of Jan Kennedy Massage & Pilates) is committed to protecting your personal information that we collect including when you access our website and services, through our business operations or directly from you.

By providing us with your personal information, you acknowledge that you have had a reasonable opportunity to read and accept the Privacy Policy and you consent to the collection, use, holding and disclosure of your personal information as outlined below.

## 1. TYPES OF PERSONAL INFORMATION WE COLLECT

We collect the following types of personal information:

- identity and contact information, including, but not limited to, your name and username, occupation, email addresses, billing and delivery addresses, telephone numbers;

- financial transaction data;

## 2. HOW WE COLLECT YOUR PERSONAL INFORMATION

We use lawful and fair means to collect your personal information in the following ways:

- you provide it to us:
- you authorise third parties to provide it to us;

We will not disclose your personal information for any purpose other than the purpose for which it was collected without your consent, unless we are required to do so by law or court order.

#### 4. USE OF COOKIES

A cookie is a small text file that is placed on your computer to help us remember your preferences, like your login information or location. We use cookies to make it easier and faster for you to use our website. We also use cookies for security purposes to protect you online. Third party vendors and we may also use cookies to display advertisements to you elsewhere on the internet.

If we agree to delete your personal information, because of backups and records of deletions, it may be impossible to completely delete your personal information without retaining some residual information. We will functionally delete your personal information and we will not sell, transfer, or use your personal information in any way moving forward.
